Colt Fire

The Colt Fire started 15 miles northwest of Seeley Lake on Monday, July 17, which was reportedly

started by lightning. This fire as of July 30th was 6,177 acres in size with 6% containment. Firefighters have been working hard to control the fire, which has increased due to higher temperatures and lower humidity.

Fire crews continued operations to secure the fire's edge along the southeast corner near Forest

Road 646 (Colt/Uhler Road). On the east side of the fire, crews are working to increase the containment percentage by mopping up along Forest Road 646, moving north. Helicopter bucket water drops were used to support burning operations. On the fire's north side along Forest Road 906 (Beaver Creek Road) and other roads, the Heavy Equipment Task Force continued to prepare control lines and mitigate fuels along roadsides in locations that have a high probability of success to contain the fire. South Structure Protection worked on structure assessments and preparation, and North Structure Protection assisted in operations along Forest Road 646 (Colt/Uhler Road) while being prepared to implement structure protection plans if conditions changed.

On the southeast corner of the fire personnel will continue firing operations and secure the line north of the West Fork of the Clearwater River and tie in with Forest Road 646 (Colt/ Uhler Road). Crews will continue to hold and mop up along the eastern control lines along Forest Road 646. On the north side, crews will hold and secure the fire along Forest Road 4356 and look for opportunities for fire control line from Colt Lake to Beaver Lake. North and South Structure Protection will assist with burning operations and holding operations on the east and southeast sides of the fire. Structure Group remains ready to respond for structure protection as needed. A night shift of engines and personnel will patrol and monitor fire conditions. Helicopters and airplanes will be used to

Eighteen individuals arrested in Bozeman during DCI human trafficking operation

HELENA – Eighteen individuals were arrested in Bozeman over the weekend during a human trafficking operation conducted by the Montana Department of Justice Division of Criminal Investigation (DCI) and Bozeman Police Department, Attorney General Austin Knudsen announced today.

The individuals have been charged with 18 counts of patronizing a prostitute, five counts of criminal distribution of dangerous drugs, one count of resisting arrest, and one count of patronizing a victim of sex trafficking for a child victim. They were charged under Montana's new statute, included in House Bill 112, that makes the solicitation of a prostitute a felony charge which Attorney General Knudsen helped write and pass during the 2023 Legislative Session.

"I'm incredibly proud of our DCI human trafficking investigators for their hard work and commitment to stopping this heinous crime in Montana. Working together with our law enforcement partners, we are getting these dangerous predators off the streets," Attorney General Knudsen said. "At the Montana Department of Justice, we are increasing our investigations and prosecutions of human trafficking to send the

message to criminals that it will not be tolerated in Montana."

"We want to use this opportunity to educate the public and reach out to those Earlier this month, Attorney in need of assistance," Bozeman Police Detective Captain Dana McNeil stated. "If someone is controlling or managing you, abusing you, withholding basic necessities from you in order to control here. you and your finances, providing you with illegal drugs, or if you feel scared, unsafe, and unable to leave the situation, seek help."

During the operation, which lasted from July 20 to July 22, investigators also seized drugs including cocaine and fentanyl. One of the individuals was also found to be an illegal immigrant who has been deported twice. If convicted, the individual charged with patronizing a victim of sex trafficking faces a sentence of up to 100 years in prison, again because of Montana's new stronger human trafficking laws.

In addition to DCI and Bozeman Police, the Montana State University Special Victims Unit and Gallatin County Sheriff's Office assisted in the investigation.

DCI's Internet Crimes Against Children Task Force (ICAC) was also involved in a law enforcement operation in the Helena area recently

that led to the arrest of four individuals who were soliciting minors online with bag. the intent to engage in sexual activity.

General Knudsen launched a new statewide public service announcement to educate Montanans on the issue and how to report it when they suspect they see it available

Know the signs. Potential indicators of sex trafficking may include:

Young person that is very hesitant to engage in conversation. Eyes are always downcast, avoiding eye contact, especially with men. Poor physical state...tired, malnourished, or shows signs of physical abuse or torture.

Seems to have trouble responding to what their name is or what location (city or even state) they are in. (Victims' names are often changed, as are their whereabouts. They typically do not stay in one location for long – at times for 24 hours or less).

Wearing clothes that do not fit the climate or the situation such as short shorts or skirts, tank tops, and no jacket in the middle of winter.

Lack of control over money, personal possessions like bags, IDs, or documents.

May also be carrying very few possessions in a plastic

May be accompanied by a dominating person, or someone they seem fearful of. That controlling person may also be someone who does not seem to "fit," such as a much older individual, an individual of a different race, or with behavior seemingly inappropriate with the suspected victim.

Young girl or boy hanging around outside a convenience store, truck stop, casino, or other location. May be approaching different vehicles or men they do not seem to know.

If you believe you witness human trafficking:

If the situation is an emergency, call 911.

Do not intervene if you see suspected trafficker(s). Remain at a safe distance or in your vehicle.

In non-emergency situations, call or text 1-833-406-STOP (1-833-406-7867) OR reach and advocate via live chat at 406stop.com.

When possible, take images with your cellular device of the suspected trafficker(s), victim(s), and vehicle license plate(s).

UPS and Teamsters Reach Deal

UPS and Teamsters, the union representing approximately 340,000 UPS workers, have reached a tentative agreement on a new five-year labor contract. This contract could potentially avoid a strike, which could have started as soon as next week.


"Together we reached a winwin-win agreement on the issues that are important to Teamsters leadership, our employees, and to UPS and our customers," said UPS CEO Carol Tomé, in her statement. "This agreement continues to reward UPS's full- and part-time employees with industryleading pay and benefits while retaining the flexibility we need to stay competitive, serve our customers and keep our business strong."

Among the issues in the contract negotiations were air conditioning for delivery vans, demands for significantly greater pay, especially for part-time workers, and the closing of pay gaps between two different classes of UPS workers.

The tentative agreement still needs to be ratified to end the threat of a strike, which will take a little more than three weeks.

Woman Killed In Bear Encounter

WESTYELLOWSTONE - A residences, campgrounds woman was killed in an encounter with a bear Saturday on the Buttermilk Trail near the town of West Yellowstone.

About 8 a.m. Saturday, game wardens with Montana Fish, Wildlife & Parks were notified that a hiker had found a woman deceased on the trail, about 8 miles west of West Yellowstone. FWP wardens and bear specialists, along with staff from other agencies, found that the woman had wounds consistent with a bear attack. They also found tracks from an adult grizzly bear and at least one cub near the site. They did not see any bears or signs of a day bed or animal carcass during the investigation.

The Custer Gallatin National Forest implemented an emergency closure of the area as a safety precaution. FWP bear specialists and game wardens notified residents and visitors nearby of the bear activity and the U.S. Forest Service closure. They then began conducting capture operations due to the incident's proximity to

and a high-use OHV trail system. No bears have been captured to date. FWP staff also searched the area from an aircraft and did not locate any bears.

The hiker was believed to be alone during the encounter, and no bear spray or firearms were found at the scene. The incident is still under joint investigation by FWP and the U.S. Fish & Wildlife Service.

FWP staff express sincere condolences to the family and friends of the hiker who was killed.

FWP thanks the Forest Service, West Yellowstone Police Department, National Park Service, Hebgen Basin Fire, Gallatin County Sheriff's Office, and Idaho Fish and Game for their collaboration.

Be bear aware

Montana is bear country. Grizzly bear populations continue to become denser and more widespread in Montana, increasing the likelihood that residents and By FWP

recreationists will encounter them in more places each

Avoiding conflicts with bears is easier than dealing with such conflicts. Here are some precautions to help residents, recreationists and people who work outdoors avoid negative bear encounters:

Carry bear spray and be prepared to use it immediately.

Travel in groups whenever possible and make noise, which can help alert bears to your presence.

Stay away from animal carcasses, which often attract bears.

Follow food storage orders from the applicable land management agency.

If you encounter a bear, never approach it. Leave the area when it is safe to do so.

Keep garbage, bird feeders, pet food and other attractants put away in a secure building. Keep garbage in a secure building until the day it is collected. Certified bear-resistant garbage containers are available in many areas.

Never feed wildlife. Bears that become food conditioned lose their natural foraging behavior and pose threats to human safety. It is illegal to feed bears in Montana.

Grizzly bears in the lower 48 states are listed as threatened under the Endangered Species Act. Management authority for grizzlies rests with the U.S. Fish & Wildlife Service, working closely in Montana with FWP, the Forest Service, the National Park Service, the Bureau of Land Management, the U.S. Geological Survey, Wildlife Services and Native American tribes. This collaboration happens through the Interagency Grizzly Bear Committee.

EVACUATIONS AND CLOSURES

The Missoula County Sheriff's Office Evacuation Warning and Order summary:

- -Residents on Beaver Creek Road (near the summit) are under an Evacuation Warning.
- -Mile marker 31 (Beaver Creek Road at the intersection of Hwy 83) south towards Seeley Lake to Smart911.com; be familiar mile marker 27, and including residences in Rovero Flats, are under an Evacuation Order.
- -Residences beginning at mile marker 27, south end of Rovero Flats, to mile marker 25.5 (the intersection of the West Fork office-of-emergencyof the Clearwater Road and Hwy 83) are under an Evacuation Warning.

and south ends of Lake Inez are under an Evacuation Warning. The east side of Lake Inez, along Hwy 83, is not under any Warning or Order.

If conditions rapidly change an Evacuation Order may be issued with no prior notice or warning. Home and property owners in the surrounding area should remain vigilant and prepared. Have an evacuation plan for family, pets, and livestock; sign up for emergency alerts at with the Missoula County evacuation process and what an order and warning means.

TEMPORARY FLIGHT RESTRICTIONS

A Temporary Flight Restriction is in place for air space over the Colt Fire (FDC 03/0291) to provide a safe environment for firefighting aircraft operating in the area. An airport closure is in place for the Condon Airstrip (FDC 07/110) for firefighting helicopter operations. Remember that temporary flight restrictions also apply to unmanned aircraft systems (UAS) or drones. A drone incursion occurred on Friday, July 21. Fire managers would like to remind the public that when you fly, they can't. It is also now a criminal misdemeanor in Montana to fly drones that interfere with fire suppression efforts – with a fine up to \$1,500 and the violator has the potential to be charged with firefighting costs.
